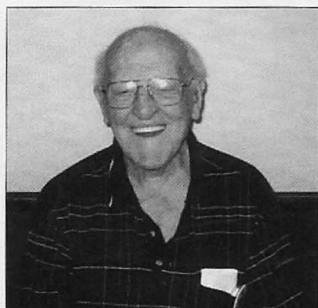

Members Profile No 2

- Arthur David Cowling O.A.M.



Born in 1919, Arthur is the son of the late Algar Cowling, partner in the firm of W.Cowling, which for many years sold Ford Motor vehicles as well as operating a successful farm machinery and grain store business in Bendigo. Educated at Quarry Hill and Bendigo High Schools, Arthur commenced his working life with his father as an assistant in the H.V. McKay Depot for farm and spare parts. He was studying accountancy when World War II intervened and he joined the infantry in the army, promotion followed and he became a captain in the Australian Intelligence Corps specializing in the analysis of enemy order of battle. When the war was over he

went back to his former job, but eventually transferred to the Ford business selling tractors, farm machinery, trucks and passenger vehicles. In 1969 the firm sold its properties and Arthur joined Provincial Motors who then held the Ford Franchise. A year later he was appointed manager truck and tractor division at Epsom and eventually managed the Ford tractor outlet of Eclipse Motors at the Palms Epsom. It was immediately after the war when Y.M.C.A. took a strong opinion on his life – he became a member of the Y's Men's Club of Bendigo and served as an active member of the Y.M.C.A. and Y's Men's Club for 63 years, filled most positions at the local club level including, President, Secretary and Treasurer to move to the wider field of the International Body and receive the movement's highest honour "The Harry M Ballantyne Award of Merit". Arthur became World President in 1992 and has served on many of Y's Men International committees.

In 1993 he was honored with an O.A.M. for services to the Y.M.C.A. and Y's Men International. Married to wife Clarice, he has four children by his former wife Norma who died 32 years ago, between them Arthur and Clarice have 16 Grandchildren and 12 Great Grandchildren. Arthur regularly attends Probus meetings.
