Our speaker for February was Lyn Hosfall and the topic was 'Understanding Dementia'. Lyn is a Dementia Consultant with Alzheimer's Australia which started in 1983. Its aim is to support and help the public and raise awareness of dementia.

Dementia is a progressive decline in normal functioning and is a normal part of the ageing process. There are 100 types of dementia and numbers of cases diagnosed are increasing dramatically. In 2011, 69,000 cases were diagnosed. This is a huge issue and the effect on future Government Policy will be of great concern.

Alzheimer's Australia works in counselling, support, awareness raising and providing information. They produce a series of Help Sheets that can be obtained from www.altzeimers.org.au

MINUTES OF THE 26th ANNUAL GENERAL MEETING OF THE PROBUS CLUB OF BENDIGO Inc. HELD AT THE MASONIC CENTRE, McIVOR ROAD, BENDIGO ON WEDNESDAY 16th MARCH 2011

The meeting was declared open at 11-05 am, by President ERN HOLLAND in the chair. All members present were welcomed.
