THE QUESTION OF INCORPORATION. In 1981 the Victorian Government introduced the Victorian Incorporation Act and your Club, in common with most other clubs proposes Incorporation under the Act. At the meeting today, you will be invited to:-

- (1) Authorise Mr. KEITH F. INGLIS to incorporate the Club under the title, 'Probus Club of Bendigo, Incorporated'.
- (2) Approve a proposed Statement of Purposes and proposed Rules.

To clarify the matter, we borrow from the Newsletter of the Aspendale Mordialloc Club,

"incorporation was designed to cover the 'grey areas' not covered by a public liability insurance policy. For instance, if a person was injured during a Probus outing ... and a club was not incorporated, legal action could be instituted against any one or all men bers of a Probus club as individuals..."

The article describes a situation, "in which a young man, secretary of a football club, was sued and was in danger of losing his home plus other financial losses, all of which could ruin him. Why? Because he had agreed, in good faith, to act as honorary secretary of his local football club and because the club was not incorporated, he was the person selected to be sued".

"...by being incorporated, no member can be sued as an individual, but the organisation (say the Probus Club) could be sued as an entity and all it could lose would be its possessions which, in most instances, would not total a great deal!"

Unless one of our millionaire members is prepared to accept responsibility, it may be prudent to vote in favour of the Executives recommendation.



"POLITICS AND THE LAW breedeth congenial bedfellows" - so wrote an ancient Scribe. This would seem to be true, since an examination of the political arena in Australia does reveal a large strata of Lawyers-cum-Politicians.

Perhaps it is because politics is largely a question of legal interpretations and innuendos.

A Bendigo citizen who has combined the two in his daily round is

well-known lawman who, for many years supported the Bendigo Branch of the Liberal Party, serving several terms as president of the branch. During one of these terms, in 1956, he

was 'hoist with his own petard'. At the time Premier Holloway appealed to all branches of the party-faithful to field candidates in every electorate, no matter how hopeless the prospect may seem. There was to be no 'armchair rides' for members of the Opposition. President Harold made great efforts to find a suitable sacrificial lamb as a candidate for one of the strongest Labour posts in the State, but failed to lead him to the post; he slipped out of the shepherd's crook a few days before nominations closed.

There was only one course open to Harold - he had to offer himself for the whipping post. He faced the redoubtable Bill Galvin whose ample proportions graced the very safe Bendigo seat on the opposition benches. Harold was soundly defeated, but he found some consolation in the fact that he had secured a record vote for the Liberals in the electorate!

Born and brought up in White Hills, Harold is the second son of ll-known Bookseller, the late Frank Every, and is a third-generation Bendigonian. His grandparents immigrated from England during Bendigo's gold-digging era.

Educated at White Hills State School, Bendigo High School and (for a short term of three months) at Carey Baptist Grammar, Harold considers himself 'one of the lucky ones'. In 1928, with the Great Depression looming, he walked out of school on a Friday and into a job on the following Monday - with the State Public Service at the Law Courts in Bendigo. In 1935 he was appointed Clerk of Courts at Wonthaggi, and afterwards at Kerang. During those years he studied for his LLB by correspondence with the University of Melbourne, a goal which he achieved after six years hard slogging.

In 1939 he found himself enmeshed in the office of the State Crown Solicitor, an appointment which successfully frustrated his many efforts

HAROLD E. EVERY ... Cont. ... to join one of the fighting services; he was in a declared 'reserved occupation'. During the war years he was engaged in work principally concerned with prosecutions for the Crown, most of them of a minor criminal nature.

In 1945 he was granted twelve months leave without pay and returned to Bendigo. Here he acquired the practice of Miss G. Alice Jones and, in turn, became the successor to her father, Fred Douglas Jones, a man widely respected for his knowledge of Mining Law.

Until the graduation of son Robert, Harold remained a lone practitioner in a legal world infested with a multitude of names, degrees and duplications. Partnership with Robert led to the birth of Every and Every, to become eventually amalgamated with the widely-respected fir of Watson, James and Rogers. Harold retired three years ago and the firm name is now Rogers and Every.

As well as his efforts for the Liberal Party, he has been a committee member (and Honorary Solicitor) for the Bendigo Home and Hospital for the Aged, a member of the Council of the BIT and legal advisor to many public organisations. He has recently retired from the council of Strath-Haven Home.

Most importantly, Harold is a member of the Probus Club of Bendigo.
